Join in now and support the IDFNZ KIDS Foundation registered charity AND your own ICONZ Company – all at the same time.

This is one fundraiser where all ICONZ Company and Church families will really want to participate. Pyro Company fireworks are a high quality and respected brand – families can achieve the convenience of their fireworks being pre-ordered to avoid disappointment and hassle of queuing to buy in November, plus they are supporting 2 very good community causes – IDFNZ KIDS Foundation AND their local ICONZ Company.

All you have to do to participate in this exciting event is:

1. Nominate a named adult Company leader to be responsible for managing and receiving orders, payments and stock delivery.
2. Distribute the printed order forms to your Company and Church families and work contacts.
3. Collect orders and payment from individual customers. NB: All orders must be from a named adult 18yrs +, fireworks cannot be legally sold to children).
4. Complete the master order form and pass on your Company order to KIDS Foundation with full payment. (Remember to provide full name / delivery address details / contact number and email).
5. We can accept orders from June 1st onwards. Final pre-order date is Monday September 1st (Term3). We recommend you order early as we have limited stock and some items may sell out.
6. We will acknowledge your order and arrange courier delivery of your order to your nominated contact in time for w/c November 2nd. (The legal period for handing over “sold” fireworks 2-5TH November).
7. You can then arrange collection by your adult customers. (A supply of fireworks safety leaflets will accompany each order to be handed to customers with their fireworks)
8. Each participating ICONZ Company will be rewarded with a cash donation to the value of **10% of their total order**. (To be paid by cheque or d/c to the ICONZ Company by December 20th).
9. ICONZ Companies will also receive an **ALL4GOOD certificate** to acknowledge their participation in our community fundraise assisting the Kids Foundation registered charity. (We can also provide **volunteer certificates** for any individual service records / Duke of Edinburgh etc. if you let us know details of Company participants championing this).

This is an **easy** and **unique** fundraiser for your ICONZ Company - a treat most families love and can only buy once a year. Any family that would normally buy fireworks will choose to support your ALL4GOOD fundraiser because they can see that it truly is a community fundraise helping 2 important groups of youths in their community.
